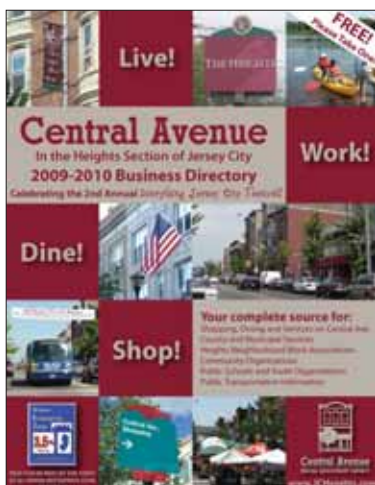

With skyrocketing prices for advertising in traditional media like newspapers, it can be hard for small businesses to find the money to promote themselves and keep customers coming through the door. To respond to this situation, the CASID will be offering several marketing programs in 2009 that are both affordable and effective in reaching the local residents that are Central Avenue's best patrons.

The 2009-2010 edition of the Central Avenue Business Directory, which will be published in spring 2009, includes a free listing for all businesses in the district and offers opportunities for them to place larger ads to highlight the products and services they offer. The Business Directory is always in demand among local residents, who

JCPA Installs Multi-Space Parking Meters on Central Avenue

As of December, the Jersey City Parking Authority (JCPA) has installed 27 multi-space meters on Central Avenue. A pole still marks each space, but instead of being topped with individual meters, the poles direct customers to the nearest multi-space meter.

Central Avenue patrons can pay for parking time on one of the new meters in three steps:

- 1) Note the number on the pole marking your space.
- 2) Enter the number in any multi-space machine on Central Avenue - you don't have to go to the one nearest to your parking space.
- 3) Keep your receipt with you - you don't need to place it on your car dashboard.



According to JCPA Chief Executive Director Mark Russ, the main benefit of the multi-space meters is efficiency. "If you look at the long run, maintenance is much cheaper on these machines than on the traditional meters," he said. If a meter does malfunction, it notifies the JCPA of the problem via a wireless signal.

In response to concerns about accessibility for seniors and people with disabilities, Director Russ has stated that traditional meters will be returned to side streets where spaces are located too far away from multi-space meters on Central Avenue. Russ will continue to lead the JCPA in making adjustments to the system as needed to increase convenience and efficiency. Anyone with questions

contact. To further increase its promotional impact, the business directory will be officially released on May 16th at the Everything Jersey City Festival, where people from around the city and Hudson County will have a chance to pick up a copy.

Beyond bringing thousands of potential customers to the doorsteps of all Central Avenue businesses on May 16th, the festival will also offer a special opportunity for businesses who become festival sponsors. Business Owners: New E-Filing Requirements for Employers in 2009

Beginning with the first quarter 2009, ALL New Jersey employers with more than 4 employees must file their quarterly wage reporting information (Forms NJ-927 and WR-30) electronically. While this new policy will increase the efficiency of the state's procedures for filing and paying employment-related taxes, it will require some planning and adjustment on the part of small businesses.

Currently there are two options to file electronically: web-based filing and bulk filing using Secure File Transfer Protocol (SFTP). Businesses can choose the one that is most convenient for them. Both of these options will provide cost savings and increased accuracy in the transmittal of information.

Gilbert Sunshine, a Certified Public Accountant (CPA) based in the Heights for over 55 years, recommends that small businesses to whom the new e-filing requirements apply "go to somebody to do it for them. You have to send the stuff in electronically, and it has to agree with [the state's] records. It's easy to punch in a wrong number and run into trouble."

Aside from Sunshine's firm, Gilbert Sunshine & Co (111 Bowers Street, 201-659-4556), there are a number of businesses on Central Avenue that can acquaint you with the new system and provide other tax, payroll and accounting services, including A.C. Plaza 2000 (428 Central Avenue, 201-795-0777), H&R Block (407 Central Avenue, 201-656-6105), J.C Professional Agency (489 Central Avenue, 201-222-5220), Malqui Tax (329 Central Avenue, 201-420-6632), Mendez Agency Nationwide Travel (263 Central Avenue, 201-792-4188), and Compass Tax (279 Central Avenue). City of Jersey City Brings Central Avenue Crosswalks into ADA Compliance

Regular Central Avenue patrons might have noticed something different about a number of the Avenue's crosswalks recently. The red brick-patterned pavers lining the curbs of Central Avenue sidewalks were removed at several intersections to make way for "detectable warning surfaces," textured rubber mats that alert people with visual impairments when they are entering an intersection.

"What we did was bring the crosswalks into federal ADA [Americans with Disabilities Act] compliance," said Vipul Patel, project manager for the City of Jersey City Division of Engineering. The crosswalk work was triggered by a city-funded repaving of side streets adjacent to Central Avenue. "For any work you do, you have to follow ADA guidelines, particularly at the crosswalks," said Patel. According to CASID President Michael Yun, "the cement curb edges may not be as visually appealing as the original red pavers were, but their installation was necessary to keep pedestrians safe and get the streets paved."

CASID Businesses: Enroll Your Business in the UEZ Program Today!

Do you see January as a new beginning? Or just the beginning of tax season? Either way, enrolling your business in the State of New Jersey's Urban Enterprise Zone Program could help make your business more competitive in the new year.

Jersey City businesses participating in the UEZ Program can access a number of financial programs designed to stimulate job creation and business growth. They can:

- charge half the state's 7% sales tax on certain purchases by customers
- enjoy a state sales tax refund on certain purchases for the business
- receive a one-time \$1500 tax credit for each new permanent full-time employee who is a resident of a municipality in which a zone is located and who had been unemployed for at least 90 days or dependent upon public assistance
- qualify for subsidized unemployment insurance costs for certain employees who earn less than \$4500 per quarter
- qualify for priority financial assistance for loans, grants and job training
- qualify for a Business Improvement Grant, a 1:1 matching grant to make facade improvements to business and/or building (maximum value \$20,000).

In addition, the whole community benefits when businesses enroll in the UEZ Program, because sales tax revenue generated within a UEZ is dedicated for economic development and public improvement projects (additional police, streetscape improvements, etc.) within that zone.

To enroll, businesses must:

- be located in Jersey City's Urban Enterprise Zone
- register the business with the State of New Jersey at the location within the UEZ
- hire and maintain a position for an additional part- or full-time employee

Business owners interested in enrolling in the UEZ Program should contact the Jersey City Economic Development Corporation (JCEDC) during regular business hours Monday through Friday. The JCEDC is located at 30 Montgomery Street, Suite 820, and can be reached by phone at (201) 333-7797, ext. 25. Ask for UEZ Director Roberta Farber. There is no cost for applying to or entering the UEZ program.

Growing the Arts in the Heights

As the arts scene in Hudson County continues to build momentum, many artists are beginning to see the Jersey City Heights as an ideal place to live, work and market their art. A group of these artists met recently with representatives of the CASID to discuss their plans for The Heights Arts Initiative (THAI).

An initial element of THAI will be a Artist Home Buying Seminar, which will be coordinated by artist Michelle Loughlin and conducted by Kate Silver of Empire Realty and Peter Olivieri of Huntington Mortgage. The seminar aims to get artists creatively and financially invested in the Heights by offering information and tools targeted to their unique needs as homebuyers and describing how good a fit the Heights is for their lifestyles and finances.

THAI and CASID representatives are also exploring possibilities for incorporating more artists into the Everything Jersey City Festival and launching other events such as a market event on Central Avenue specifically for artists and indie designers. They also discussed adding more arts content to the Heights News, the Central Avenue Business Directory and JCHights.com as a way to make the public aware of the Height's growing arts community.

In the long term, the local artists developing THAI see a potential for a permanent arts presence in the Heights, including studio/gallery spaces in storefronts on Central Avenue that would draw new visitors who could in turn become new shoppers and diners at Central Avenue's stores and restaurants. "For businesses and the CASID, supporting the development of the arts in the Heights just makes sense," said CASID president Michael Yun. "Artists help us see what is unique and beautiful about our community, and their creative investment also stimulates the local economy. We stand behind the The Heights Arts Initiative one hundred percent and look forward to helping it promote a vibrant arts culture in our neighborhood."

CENTRAL AVENUE BUSINESS SPOTLIGHT: Christian Jewelers

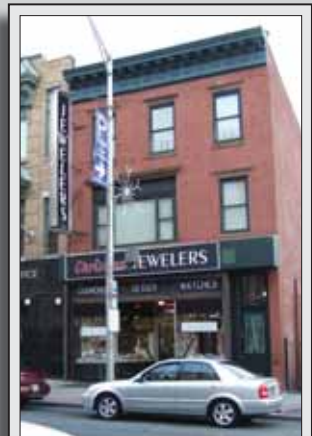

The vertical JEWELERS sign at 390 Central Avenue is a familiar landmark for the many drivers and pedestrians who pass through the Avenue every day. But the business it advertises, Christian Jewelers, is a true Jersey City institution that has been serving the Heights since 1910. John Wascoe, one of the three business partners who bought the business from the Geiger family in 1975, got his start in jewelry when he started working as a messenger for another Central Avenue jeweler in 1963. He now runs the store full-time with Bill Sittmann, an employee who has been with the business for over 30 years.

Things have changed a lot since the Ritz Theater was Christian Jeweler's next-door neighbor. Many of the store's vendors have changed hands or gone out of business, and the items in demand have changed over time as new generations have moved into the neighborhood. Currently, John says that watches, Journey Diamonds, Past, Present and Future Diamonds, earrings, and jewelry made out of silver, white gold and platinum are the most popular items they sell. Sales go up and down with the economy, but after many years, the business has earned the trust of many loyal customers who come back to get heirlooms repaired as well as to make new purchases. John and Bill's experience and expertise don't hurt, either - Bill is skilled in engraving and jewelry repair, and John has completed training at the Gemological Institute of America and is a certified Diamond Master. "After being here so many years, we've seen people's children grow up" John said. "It's nice that they're not just customers, they're friends."

Ward D Councilman Bill Gaughan's 2009 Outlook for the Heights

With an eventful 2008 behind us, it's time to look forward to what is in store for the Heights in 2009. To gain insight in doing so, we can turn to Ward D Councilman Bill Gaughan, who has been representing the Heights on the City of Jersey City Municipal Council for 16 years and also serves as Chief of Staff for Hudson County Executive Tom DeGise, giving Heights residents a voice in both municipal and county government.

"One of the highlights that is already in process is the construction of 40 new condo units on Summit Avenue between Secaucus Road and Hague Street," said Gaughan. The 2-bedroom townhouses will sell for \$225,000, which will make them affordable for people who work in Jersey City and also want to be able to live here, like firefighters and teachers. The property where the new units will be built has already been acquired, and construction is scheduled to start this spring. The economic downturn will not hold the project up because its funding (\$14 million) is already secured.

Another initiative Gaughan is interested in bringing to the area is a "Taste of the Heights" event featuring the culinary offerings of local restaurants. Similar programs like Taste of Hudson have been successful in acquainting diners with the cuisine available right in their own neighborhoods.

Recently, concerns have been raised about the efficiency of the city's permitting process for renovations and new construction. "I am proposing that the mayor appoint an official liason to assist those seeking permits in addressing problems with city inspectors and building contractors," Gaughan said. This would give business

owners additional leverage in dealing with problem contractors and would promote accountability and efficiency among city inspectors, with the ultimate aim of making the permitting process easier and faster for new businesses and residents.

Gaughan also continues to advocate for a modernized JCPD North District precinct in the Heights and an ordinance to better regulate itinerant ice cream vendors that compete with local businesses and tie up pedestrian traffic on Central Avenue during the summer.

Beyond these specific initiatives, "I'm also always looking for ways to improve basic services in the Heights like public safety, sanitation and parking, so that our public agencies are attentive to the needs of Central Avenue," Gaughan said. The CASID looks forward to continuing in partnership with him in 2009 to bring about further positive developments for the Heights.

Zone Program.

Given the current economic difficulties, the festival will bring a much-needed stimulus to the local economy. Exhibitor booths will once again be placed in the center of the street to gain maximum exposure for Central Avenue storefronts, and in 2009, CASID member businesses will have additional opportunities to benefit by participating in a one-day sale promotion in conjunction with the festival and by becoming festival sponsors at special rates (see marketing article on page 2). Community organizations will again be able to reserve discounted booth spaces for fundraising, public relations and member recruitment. The local arts scene will also be a presence at the festival through the participation of key local artists and arts organizations. Together, these efforts will make the festival a bright light and a necessary boost for Jersey City during a year that is expected to bring more economic struggles.

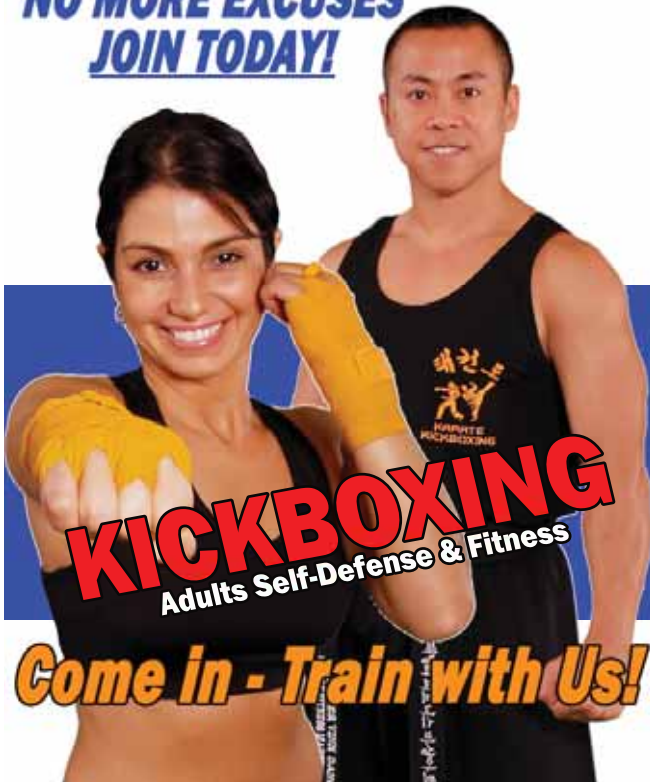

STREET MAINTENANCE OPERATION

ASSISTING CENTRAL AVENUE MERCHANTS IN KEEPING A CLEAN AND PRESENTABLE MAIN STREET ENVIRONMENT

The Central Avenue Street Maintenance Operation (SMO) staff can be seen daily on Central Avenue, removing trash and serving as ambassadors for shoppers and business owners alike.



SMO staff clear a Central Avenue crosswalk after a snowfall. In partnership with business owners, who are responsible for removing snow and ice from their sidewalks, the SMO keeps public fixtures and crosswalks clear to keep commerce moving on Central Avenue throughout the winter months.

Reminders from the CASID

- Business owners **must** sweep their sidewalks every day upon opening
- Please don't litter - use the public wastebaskets available on Central Avenue instead
- DO NOT dispose of household or business waste in public wastebaskets
- If you need directions or assistance on Central Avenue, ask a member of the SMO staff. They will be glad to help!

Central Avenue Sanitation Collection Schedule

Garbage

Monday and Thursday Nights ONLY

Garbage may be put out AFTER 7 PM and may be placed ONLY in front of your OWN property.



To schedule a pickup of furniture or other bulk waste, call the Jersey City Incinerator Authority at (201) 435-1345.



Recycling Tuesday Nights ONLY

Paper must be tied in bundles. Other recyclables (plastic, glass, cans, etc.) are collected in large plastic containers, NOT plastic bags.

Snow Removal Guidelines

All business owners are required by law to remove ALL snow from their sidewalks within four hours of a snowfall (or four hours of sunrise if snow falls overnight). If any ice remains, owners must apply sand or salt.

The CASID SMO assists business owners by clearing snow from public spaces such as crosswalks, garbage cans and benches, but SMO staff will **NOT** clear sidewalks for Central Avenue businesses.

The CASID advises all member businesses to do their part to keep Central Avenue safe, accessible and pleasant for shoppers and local residents.
